

## **Privacy policy**

The bennettfleet.ca website is owned by *Cartons Plats et Fibre Bennett Fleet*, which is a data controller of your personal data.

We have adopted this Privacy Policy, which determines how we handle information collected by bennettfleet.ca and provides the reasons why we need to collect certain personal data about you. Therefore, you should read this Privacy Policy before using the bennettfleet.ca website.

We take care of your personal data and are committed to guaranteeing its confidentiality and security.

### **The personal information we collect :**

When you visit bennettfleet.ca, we automatically collect certain information about your device, including information about your web browser, your IP address, your time zone and some of the cookies installed on your device. In addition, as you browse the site, we collect information about the individual web pages or products you visit, the web sites or search terms that referred you to the site and how you interact with the site. We refer to this automatically collected information as "device information". In addition, we may collect the personal data you provide to us (including, but not limited to, last name, first name, address, payment information, etc.) during registration in order to perform the contract.

### **Why do we process your information?**

Our top priority is the security of customer data and, as such, we can only process minimal user data, only where this is absolutely necessary to maintain the website. The information collected automatically is used solely to identify potential cases of abuse and to compile statistical information on website use. This statistical information is not otherwise aggregated to identify any particular user of the system.

You can visit the website without telling us who you are or revealing any information by which anyone could identify you as a specific, identifiable individual. However, if you wish to use certain features of the website, or if you wish to receive our newsletter or provide other details by filling in a form, you may provide us with personal data, such as your e-mail address, first name, last name, city of residence, organization, telephone number. You can choose not to provide us with your personal data, but you may not be able to take advantage of certain website features. For example, you may not be able to receive our newsletter or contact us directly from the website.
